

## Inhabit Realty Group and Placemaker Real Estate Complete Purchase of Park Vista Apartments

Chicago, IL, September 12, 2023

A partnership between Inhabit Realty Group, a Chicago-based real estate investment firm led by A.J. Manaseer and Placemaker Real Estate, a Miami-based firm led by Adriel Deller, has acquired Park Vista Apartments (formerly known as Tuscany Cove), an 84-unit apartment complex in Champaign, IL. The property was acquired in an off-market transaction for \$5,225,000 (\$62,202 per unit), brokered by Marco Cesario of Jameson Commercial Real Estate.

"We are excited to sponsor this acquisition in Champaign-Urbana, which is a new market for us," said A.J. Manaseer, Principal at Inhabit Realty Group. "Champaign has been somewhat under-the-radar from a national perspective. But the fundamentals are strong here and we believe that strength will continue."

One reason for that strength is the growth in enrollment at the University of Illinois at Urbana-Champaign, the system's flagship campus. "U of I has been consistently breaking enrollment records the past few years and their 23-24 freshman class is the largest in history," said Adriel Deller, Principal at Placemaker Real Estate. "And with total enrollment also an all-time high, this will be a boost for the local economy."

"In addition, we like the fact that the construction pipeline in Champaign-Urbana is thin," added A.J. Manaseer. "There are few projects being developed or being planned and every one of them is student housing. We expect this supply constraint to be beneficial to investors and operators of affordable housing in Champaign-Urbana."

Tuscany Cove Apartments is a value-add apartment complex built in 1984 with the most recent addition completed in 1999. The 84 units consist of 1, 2, and 3 bedrooms and are spread across 7 buildings. The property is across the street from Parkland College (a community college that feeds into the University of Illinois) and walking distance to a bustling Kraft-Heinz macaroni and cheese production facility.

The acquisition was funded with a \$3,762,000 loan from Morton Community Bank and \$2,000,000 from private equity investors. The property will be managed by Ramshaw Real Estate Property Management. This closing represents the fifth syndication for the partnership between Adriel Deller and A.J. Manaseer. Previous syndications have included portfolios of student and multifamily housing in the Bloomington-Normal market.
